CORPORATE Season Pass

\$25,000.00

This pass includes*:

Greens fees for four golfers per day for the season described as:

- Four ***designated primary pass holders*** may play any time any day, or
- ***Non-designated*** guests may play any time Monday thru Friday, and Saturday, Sunday and Holidays after 12:00 P.M. only.
- Starting October 15th only the 4 designated pass holders can play on Saturday & Sunday before 10:30am. (Dates are subject to change)

A representative of your organization is responsible for making sure that there is only one foursome per day. **If more than one foursome is booked, you will be charged for the additional players at the appropriate published rate.**

Range use for the season described as:

- Unlimited range use for four ***designated primary pass holders*** any time any day
- Non-designated guests have unlimited use of the range, day of play only.

Additional pass features:

- 14-day advance tee times (times may be reserved directly though our Golf Shop)
- USGA/GHIN handicap for four (4) designated primary pass holders
- Only the 4 designated primary pass holders may enter the Club Championship

*In addition to the privileges highlighted above, please review the following Rules and Regulations associated with your Season Pass status. All other Rules & Regulations of Centennial Golf Club apply.

1. Tee times for additional golfers will be charged the appropriate published rate.
2. **Cancellations must be made at least 24 hours in advance. A \$50.00 per player fee will be charged to the credit card on file for any "no show".**
3. Any and all fees paid for a Season Pass are non-transferable, non-refundable and will not be prorated.

A deposit of \$5,000.00 is required at time of application and balance to be paid by March 15, 2012. All checks should be made payable to *Centennial Golf Club of New York*, and mailed to Centennial Golf Club, 185 John Simpson Road, Carmel, NY 10512.
